Historical/Biographical Notes

Col. James Drennan was one of the most famous individuals in Worcester's history. He was said to have been known to more Worcester people than any other one citizen and his career as a public man, has been long and varied. He was born in Ireland, Dec. 25, 1834 and was 70 years, 10 months and 12 days old. When he was a very small boy, his father and mother, Martin and Joan Drennan, came to the United States and bought a farm in Holden where the boy worked. It was in Holden that his early schooling commenced. As a youth he came to Worcester and learned the carpenter's trade of George Hapgood and followed that business up to 1861. His military career started soon after his coming to Worcester when he entered in the Worcester Light Infantry and rose to the rank of Lieutenant. When the war broke out, Col. Drennan gave up his commission in the infantry and enlisted in the Twenty-fifth regiment as a private. He was made a second lieutenant of Co. K of that regiment before it left Worcester, the commission being dated Oct. 12 1861. He was commissioned a first lieutenant in the same regiment July, 1862 and acted as quartermaster through the year 1863-4. He was commissioned a captain on June 4, 1864 and as such was mustered out at the expiration of his terms of service, Oct. 20 1864. In speaking of Col. Drennan, Gen. Josiah Pickett who commanded the Twenty-fifth regiment said he was a very efficient and brave soldier. Immediately after the close of the Civil War, Col. Drennan identified himself with the state militia and in 1875 was made Colonel of the Tenth Massachusetts regiment which included the Worcester companies. In 1865, he was appointed deputy marshal by Mayor Phinehas Ball, and thus began his connection with the police force of Worcester. In 1872, he was appointed a member of the state constabulary and served until the reorganization into the present state office. He was appointed deputy sheriff on June 1, 1875, and served in that capacity continuously since then. Since his initial appointment to deputy marshal in 1865, Col. Drennan served a total 41 years with the police and sheriff's departments of the city, county and state. Probably no officer in the state had a wider experience among the criminals of the state. He knew Worcester thoroughly, and even in his time days when it was a much more wicked city, he was able to keep track of the floating population of crooks and suspicious characters. His reputation among the citizens of the under-world was widespread and this reputation, which accredited him with the ability not only to detect crime, but also to forestall it, undoubtedly saved the city from many crimes. Col. Drennan was survived by his wife and three daughters. Lillian Agnes Bigelow, wife of Irving E. Bigelow; Sarah Porter Lange, wife of A. H. Lange; and Ada Barton Somers, wife of E. J. Somers. Mrs. A. S. Lowell, who died in Rome in 1900, was also his daughter. Two sisters, Mrs. J. M. O'Reilly and Mrs. B. G. Doyle also survive.

Scope and Content

The collection contains eight boxes which contain all the records of James Drennan. Included are records of his military service in the Civil War, cases he worked on as a police officer for over 40 years and various receipts and miscellaneous correspondences. There are also two oversize volumes that were his handbooks when he was Worcester City Marshall.
