Collection Information

 $\underline{\text{Abstract}}$: The collection contains 28 letters, various sizes, dating from 1799 – 1849, relating to the notable and important Green Family, which played a significant role in developing Worcester, MA and New York City.

Historical/Biographical Notes

The estate known as "Green Hill" was purchased by Dr. Thomas Green of Leicester, Massachusetts in 1754 and was inhabited by his descendents as a family home until 1905 when it was purchased by the city of Worcester for a public park. The estate consisted of approximately 500 acres of land with a farm, stone quarry, and a large mansion.

The collection also features a large amount of material relating to the inheritance of the Green Hill Estate following Andrew Haswell's death in 1903. The heirs of the estate were Andrew's five nieces and nephews: Lucy M. Green, William Ogden Green, Mary Pomeroy Green, Samuel Martin Green, and Nathan W. Green.

Finally the collection features materials relating to the controversial 1960s proposal to construct part of I-290 over part of the Green Hill Park.

Scope and Content

The collection contains 28 letters, various sizes, dating from 1799 – 1849, relating to the notable and important Green Family, which played a significant role in developing Worcester, MA and New York City.

The grouping includes four letters to and from William Elijah Green to his Providence, RI, friend Col. John Whipple; a letter from noted Boston attorney Henry Leavitt Ellsworth; eleven letters from friend Levi Thaxter of Watertown, MA. The collection also includes three family letters wholly or partly written by William's famous son Andrew Haswell Green,
