Collection Information

<u>Abstract</u>: Documents relating to renovation and remodeling of Harrington dwelling on William Street during the late 1940s, with old deeds to property acquired by Harrington family in Worcester and Grafton, along with maps, pamphlets, and other items provide insight into life and interests of Frank L. Harrington, lawyer and President of Massachusetts Protective Association, and active in insurance matters in Worcester from the 1930s to the 1960s.

Historical/Biographical Notes

The Harringtons were an English family that emigrated to this country in 1634. Francis Harrington settled in Grafton in 1736, and in 1740 located in Worcester. Frank L. Harrington was an attorney, later became President of Massachusetts Protective Association, the former Masonic Protective Association. This insurance company established the Paul Revere Life Insurance Company, and ultimately lost its identity to the new company. Frank L. Harrington was grandson to Francis Alfred Harrington, Mayor of Worcester in the 1890s. Harrington acquired a dwelling at 98 William Street, thoroughly renovated it and lived there until his death in 1988.

Scope and Content

The collection includes bills, receipts, and other documents relating to the renovation of the house at 98 William Street, 1947-1949; copies of 18th century deeds to land in Grafton acquired by Francis Harrington, and of land in Worcester acquired four years later. Also included are 19th century maps of Worcester, a plan of the Meeting House pew ownership in 1763, and miscellaneous photographs.
