Historical/Biographical Notes

David F. O'Connell was born in Ireland in 1858, and emigrated to Worcester with his family at age six. He became a lawyer, and served in the state legislature, on the Worcester Common Council, and the Board of Aldermen. He was elected Mayor of the city and served one term in 1912.

An oil painting of Mayor O'Connell was done by Emily Waite. This portrait was offered to the city by Mayor O'Connell's son, James S. O'Connell, in 1964, for display with portraits of the mayors of Worcester, and restored at his expense.

Scope and Content

The collection consists of three letters to James S. O'Connell from Mayor Paul V. Mullaney, written in early 1964, relating to the painting of O'Connell's father, Mayor David F. O'Connell, displayed in Worcester City Hall. Photographs of Mayor O'Connell and of the painting were removed from the collection and shelved by genre.
