Historical/Biographical Notes

John E. Peters was the owner of the John E. Peters Photographic Supplies store on 22 Pearl St. Worcester, Ma. He was born October 1867 to John L. and Mary F. Peters. Previous to being a photographer he was a clerk in 1886, then an engraver and finally a photographer. He was married to Clara Maud Chase Peters in 1902. He boarded at Brooks Corner in Malden. He moved his business to Gardener Massachusetts in 1903. He lived out the rest of his days in Holliston Massachusetts. He had two sons: John L. Peters born in 1904 and Robert H. Peters born in 1908

Scope and Content

Collection contains John E. Peters Photography Supplies Store, photographs and advertisements, some correspondence and objects. Two collections were donated by Ruth Gjeltema. One was donated on February 16, 1995 and given the accession 1995.12 and the other was donated on April 4, 1995 and given the accession 12.27. The two collections were combined and became accession number 1995.12. According to the gift arrangement the following items were missing when processing the collection: 1 "Norton Products" pamphlet, Norton Co., Worcester, 1 photograph of new Union Station at night, 1 photograph of old Union Station, 1 envelope from Denholm & McKay Co., to Mrs. J. E. Chase, 16 years, 1891", 1 Worcester Pressed Steel Museum pamphlet, 1 photograph of "Blackstone River Millbury, Mass.
