<u>Abstract</u>: The Shaarai Torah membership ledger provides a list of synagogue members and dues pain to the synagogue from the 1950s to the early 1990s, and illustrate declining membership and income during the final years of the synagogue.

Historical/Biographical Notes

Congregation Shaarai Torah was established in 1904 and built a synagogue at 32 Providence Street in 1906, one of many small neighborhood synagogues built during the early 20th century throughout the country during a period of extensive immigration of Eastern European Jews to the United States. Some eight synagogues existed in the eastern part of Worcester through the 1940s. By 1990, only Shaarai Torah was left. The earliest Jewish immigrants settled in eastern Worcester, in the densely populated area around Green and Water Streets. Upward mobility and changing demographics of the city caused a dispersal of the Jews from their clustered east side neighborhoods, to a more even distribution throughout the city.

The records of the last twenty years of Shaarai Torah indicate the major problems of declining membership rolls, increased costs, deficit budgets, and increasing age of remaining membership. Formal records of the Congregation are sparse during the last few years of its life, as only a small number of members kept the synagogue open through volunteer efforts. The decision was made to sell the property in 1995, as remaining members were no longer able to maintain the building or keep it open.

The membership ledger, 1950s-1990s, provides insight into the financial situation of the synagogue and decline of membership during the last decades of ts existence.

Letters and other documents inserted in the ledger concern dues payment, 1980s; thank you notes, requests for membership, 1960s; a membership list, n.d.; and legal documents approving the use of the synagogue property by the Second Baptist Church, 1989.
