#### Historical/Biographical Notes

John W. Wetherell and Hester Newton Wetherell were related to some of Worcester's most prominent nineteenth century families. Born in 1821 and 1823 respectively, they resided in a house on State Street after their marriage. John, in addition to other business interests, was a lawyer with his own law practice in the city, and between them John and Hester also owned a large amount of property in Worcester and elsewhere in central Massachusetts. One such property was on Newton Hill, which was sold to the city in 1888 and incorporated into Elm Park. John also had strong connections with Boston, where he served as an aide to Governor John Andrew during the Civil War, and was involved in the Republican Party politics. Hester, for her part, was heavily involved in many Worcester organizations, including the Worcester Children's Friendly Society, of which she was the treasurer for many years. John Wetherell died in 1897 after a quiet retirement spent mostly in Worcester, and Hester followed him two years later. Though the couple had no surviving children, she made provision in her will for numerous Worcester institutions, friends and relatives.

#### **Scope and Content**

The collection includes the papers of John W. Wetherell and his wife Hester Newton Wetherell, primarily from the 1860's, but extending from the 1840's to the 1890's. Most of the material relating to Hester, However, is drawn from the Kinnicutt Family Papers (1973.11) and were moved from that collection to this one. Within the collection are letters and documents relating to the business activities of John W. Wetherell and his wife Hester, including financial and property matters, as well as a few legal issues. Additionally, it contains many letters relating to Colonel Wetherell's service as an aide de camp on the staff of the Governor of Massachusetts during the Civil War, mostly from petitioners seeking his influence to obtain an appointment as an officer. Furthermore, there is an assortment of papers relating to the organizational involvement, political activity and social engagements of both John and Hester. Finally, there is a notebook containing the records of John's tenure as a Justice of the Peace during the 1850's, and another with court records from the 1870's and some material on the history of Brookfield.
