### **Historical/Biographical Notes**

The estate known as “Green Hill” was conveyed to Dr. Thomas Green of Leicester, Massachusetts in 1754 and was continuously owned by members of the family until 1905 when it was purchased by the city of Worcester for a public park. The estate consisted of approximately 500 acres of land with a farm, a stone quarry and a large mansion. The residence was begun by Dr. John Green (1736-1799) in 1757 and enlarged by Elijah Green (1777-1865)

and Andrew Haswell Green (1820-1903). After it was sold to the city, the 42-room mansion was used for parties, dances, and entertainment. The building was torn down in 1957 due to deterioration.

William E. Green (1777-1865), a son of Dr. John Green (1736-199) was born on the Green Hill Estate. He graduated from Brown University in 1798 and practiced law with Edward Bangs and Edward Bangs, Jr. He had three wives and eleven children including Lucy Merriam Green (1810-1893), Lydia Plympton Green (1824-1869) and Andrew Haswell Green.

William N. Green (1804-1870), the eldest son of William E. Green and only child of Mr. Green's first wife Abigail Nelson served as Judge of the Worcester Police Court for 20 years, from the organization of the city in 1848. William Nelson Green married Sarah Munroe Staples in 1839 and had a son, William Nelson Green, Jr. born 1843 and died in service during the Civil War. His second son, Timothy Ruggles Green was born in 1844.

Dr. John Green III (1784-1865), a nephew of Elijah Green and last of the three generations of Worcester doctors with the same name, began to practice medicine in 1807. He attended Harvard and Brown Universities and was active in a variety of Worcester organizations. Dr. Green was an avid book collector and is best known as a major benefactor to the Worcester Free Public Library. He married Dolly Curtis and they had no children.

Andrew Haswell Green (1820-1903), a son of Elijah Green, attended the local schools in Worcester. He moved to New York where he eventually became a lawyer. He held various public service jobs and was the comptroller for the Central Park in New York City. Through his work annexing land for the city, he became known as the "Father of Greater New York". Green was killed, in a case of mistaken identity in 1903.
