Historical/Biographical Notes

The Midas club was formed in 1927. For a sum of \$5.00 a share monthly, beneficiaries could invest in the trust. The trust was run by 5 elected trustees who could invest and re-invest the funds of the trust according to their own discretion. The idea of forming the club originated with John Richardson. In collaboration with Dr. Gage, he prepared a list of prospective members and in the early part of November 1927.

Scope and Content
