Historical/Biographical Notes

H. Ladd Plumley was born in Waterbury, Connecticut in 1903. He attended the Hotchkiss

School, from which he graduated in 1921. He then went on to Williams College, where he graduated in 1925 with a Bachelor of Arts degree. While in college, he worked as an apprentice toolmaker, a freight-yard laborer, and Fuller Brush man, among other things.

Plumley was a Lieutenant Colonel in the US Army during WW II, and he served as the administrator of the National Service Life Insurance Program. After leaving the army in 1945, he joined State Mutual Life Insurance Company of America (now Allmerica Financial) based in Worcester. He was put in charge of the fledgling group insurance operation, which he quickly built up into a major division of State Mutual, with \$617 million of combined group and casualty coverage.

Plumley was elected president of State Mutual and in 1960 became the chairman of board of directors, a position he held until his retirement from the company in 1967. He received numerous awards and honorary degrees during his lifetime. Outside of State Mutual, Plumley was the president of the US Chamber of Commerce in 1962 and 1963. He served on numerous board and committees throughout the City of Worcester.

Plumley became the head of the Worcester Housing Authority in 1978. Previously, he had helped spearhead the construction of Plumley Village East, a housing project that was originally run by State Mutual.

Plumley was married to Christine A. Larsen; he had two daughters, Nancy and Susan, and had several grandchildren and great-grandchildren. He died on April 17, 1990 at the age of 87.

Scope and Content

The first series of this collection contains speeches written for Mr. H. Ladd Plumley for various social and business conferences while the second series contains military records of extracts from the War Department, several memorandums to officers in the military, and letters

written to and by Mr. Plumley.

The third series consists of letters of congratulations, tributes, and certificates from awards received by Mr. Plumley. The two main awards include the Big Brothers Award and the Isaiah Thomas Award.

The fourth series consists of honorary degrees awarded to Mr. Plumley from various colleges as well as photographs. The fifth series contains miscellaneous book material mainly from childhood while the sixth series contains miscellaneous material regarding the iris flower in flower shoes throughout New England.

The seventh series consists of publicity for retirement with various letters of congratulations. The eighth series contains relations to sound including speeches and celebrations. The ninth series contains two medals, one for service from World War II and another for military merit.

The tenth series consists of miscellaneous photographs from conventions to awards to golf tournaments. The eleventh series contains a single scrapbook presented upon Mr. Plumley's 10th anniversary of heading the State Mutual Life Insurance Company.

The twelfth series contains various newspaper clippings from around the world containing information in regards to visits and progress of Mr. Plumley. The final series is a collection of miscellaneous documents in relation to Mr. Plumley.
