Collection Information

Abstract : This collection contains 3 boxes of papers concerning the Salisbury Mansion Associates. The Salisbury Mansion Associates took over management of the Salisbury Mansion from the Worcester Art Museum in 1955. These documents, letters, and newspaper clippings describe the formation of the Associates and the subsequent renovation and transfer of the Mansion to the Worcester Historical Museum in 1985.

Historical/Biographical Notes

Prior to 1955, the Worcester Art Museum owned and leased out the Salisbury Mansion. In 1955, the current lessee, the Worcester Employment Society sought permission to alter or tear down the Mansion to better fit their needs. After permission was denied, a group met to discuss the future of the Salisbury Mansion. The Salisbury Mansion Associates took on the task of preserving the historic home in 1955. The Mansion was leased out to various organizations, like the Girl Scouts of America, until the early 1980's when the Worcester Historical Museum took an interest.

The Worcester Historical Museum and the Salisbury Mansion Associates worked together to restore the Mansion into a historic house museum devoted to a period between 1835 and 1850. After extensive renovations beginning in 1980, the Salisbury Mansion opened to the public in 1984. As per the agreement between the Associates and the Worcester Historical Museum (WHM), ownership of the Salisbury Mansion was eventually transferred to the WHM in 1985 with the continued supervision of the Associates.

Scope and Content

This collection contains 3 boxes of papers concerning the Salisbury Mansion Associates. The Salisbury Mansion Associates took over management of the Salisbury Mansion from the Worcester Art Museum in 1955.
