Collection Information

Abstract : Collection contains membership ledgers of dues and donation as well as bank statements, bills and receipts, and lists of donations and membership for the Shaarai Torah Congregation. There are also correspondences for the betterment of the Synagogue and ones from the Curator of the WHM about information about past members. Also listed are documents about the Beth Israel Synagogue and Worcester Hebrew Cemetery.

Historical/Biographical Notes

The first Jewish religious service was held in Worcester in a room at the German Frohsinn Club in 1877. Sons of Israel Synagogue was established that same year. In 1886 a second synagogue was listed in the city directory, and eight by 1916. Congregation Shaarai Torah was established in 1904 and built at 32 Providence Street in 1906. In the early 1920s, many of the residents of the old Jewish neighborhoods moved away to the newly developing suburban areas of the West Side of the City. East Side congregations dwindled and caused a merging of many of the Jewish congregations. By 1948, one of the last of these, Sons of Abraham, reduced to only forty-eight members, merged with Shaarai Torah. In 1979, there were believed to be about sixty Jewish families living on the East Side. By 1991, 21 members remained. The Synagogue closed in 1996. In the late 1990s, philanthropist Albert Tapper, president of The Provident Foundation, purchased the building with plans to make it into a museum to commemorate the East Side's once-thriving Jewish community. A fire in September of 1999 destroyed all hope for renovation. In 2002, the building was purchased by Selim Lahoud, who planned a 1.1 million dollar project to convert the synagogue into 13 condominiums.

Scope and Content

This collection contains membership ledgers of dues and donation as well as bank statements from the late 1930's to the late 1960's. There are also bills and receipts and lists of donations and membership of every individual part of the Shaarai Torah Congregation. Several correspondences requesting aid and money for the betterment of the Synagogue are present as well as miscellaneous documents regarding the Beth Israel Synagogue and Worcester Hebrew Cemetery. Also listed among the collection are letters from the Curator of the WHM (at the time the Synagogue was in session) regarding information about past members.
