### **Historical/Biographical Notes**

The Worcester County Institution For Savings opened on June 11, 1828 by a distinguished group of Worcester men “as an encouragement to young men and others to lay up a portion of their wages instead of wasting them.” It was the first such organization in the county. That year there were 81 depositors. The first president was Daniel Waldo, lived on the upper floors of the bank building, which is now the Central Exchange Building. By the year 1848, its assets exceeded \$1,000,000. The bank moved several times because it either outgrew its location or fires. It was located on Brinley Row for a few months until a new Central Exchange Building was completed in 1843. By 1906 they had outgrown their space and opened the new bank on the corner of Foster and Main Street in October. The bank was bought out by BankBoston in the early 1990s.

### **Scope and Content**

Collection contains the bank records of the Worcester County Institution For Savings from 1830s – 1990s. Included are cash ledgers, daily deposit ledgers, statements, reports of the Board of Trustees, Scrapbooks and photographs
